Owner reserves the right to reject any or all Bids, waive any informalities, or negotiate with the low Bidder as described in the Instructions to Bidders.

Contractor registration in accordance with Title 2.2, Chapter 43 and Title 54.1, Chapter 11, Code of Virginia is required.

The Project or Work consists of construction of approximately 6,300 linear feet of 48-inch HDPE transmission force main, 3,700 linear feet of 12-inch and 30-inch SWIFT water main, 3,700 linear feet of 16-inch Back Flush main, 3,400 linear feet of communications conduit, trenchless crossing of I-664, removal and disposal of contaminated soil and groundwater, clearing and grubbing within HRSD easements and site work including paving.

A pre-bid conference will be held in the SWIFT Research Center conference room at the Nansemond Treatment Plant on March 28, 2024, at 1:00 p.m. local time. Attending the conference shall not be mandatory for those submitting a Bid.

A Bid Bond in the amount of 5 percent of the Bid shall be submitted electronically with each Bid.

This project is being funded in part under the Virginia Clean Water Revolving Loan Fund (VCWRLF). Bidders shall comply with the President's Executive Order No. 11246 (Prohibiting discrimination in employment regarding race, color, creed, sex or national origin), No. 12138 and No. 11625 (Regarding MBE/WBE utilization). Bidders shall also comply with the Civil Rights Act of 1964. Bidders must certify that they do not and will not maintain or provide for their employees any facilities that are segregated on
