Primary Facility Contact

All BMP requirements are enforceable even if the primary facility contact changes. Notify your inspector immediately if contacts change so they can familiarize any new contacts on the BMP requirements.

Passivation

HRSD is constantly learning more about the manufacturing of alcoholic beverages and how the wastewater affects the sewerage system and ultimately our wastewater treatment plants. To continue our learning process, please continue to notify your inspector when passivation processes occur on-site for possible sample collection.

Tax and Trade Bureau (TTB) Reports

As stated in Section 10 of the BMP, HRSD understands that a good portion of water utilized by the facility has the potential to not be discharged to the sanitary sewer due to the water being contained in the final product. To receive this deduction, a copy of the prior year's Department of Treasury TTB reports must be submitted annually to our office. Calendar year 2021 TTB reports will be due by **January 31**st, **2022**. Credit will be applied in the Spring of 2022. Please see the submittal section below.

Pollution Prevention (P2) Awards

Each year HRSD honors businesses and industries for outstanding pollution prevention (P2) measures. P2 awards are presented for multi-media (air, land, water) efforts that focus on reduction of waste (or its toxicity) at the source rather than traditional treatment, control, and disposal. Some examples include raw material substitution, installation of clean manufacturing technologies, in-process recycling, as well as preventive maintenance and spill prevention. Starting in 2020, a separate category was created for Alcohol Beverage Manufacturers. As a BMP holder, you are eligible to apply for this award. If your facility is selected as a winner, you will be invited to receive your award at the Pretreatment and Pollution Prevention Awards banquet.
