Contractor registration in accordance with Title 2.2, Chapter 43 and Title 54.1, Chapter 11, Code of Virginia is required.

The Project or Work consists of the construction and testing of 7 managed aquifer recharge (MAR) wells and 2 monitoring well nests at the HRSD James River Treatment Plant site and adjoining properties. This project is part of the HRSD multi-phase managed aquifer recharge program to implement the Sustainable Water Initiative for Tomorrow (SWIFT) program.
