The Hampton Roads Sanitation District (HRSD) (Owner) will receive electronic Bids for the above referenced project online through Owner's Online Oracle Enterprise Resource Planning (ERP) system (<https://www.hrsd.com>) by July 15, 2025, no later than 2:00 p.m. local time. Failure to submit a Bid through Owner's Online Oracle ERP system prior to the due date and time will be cause for rejection by Owner. Procedures for submitting a Bid, claiming an error, withdrawing of Bids and other pertinent information are contained in the Instructions to Bidders. Owner reserves the right to reject any or all Bids, waive any informalities, or negotiate with the low Bidder as described in the Instructions to Bidders.

Bid Documents may be viewed by logging into Owner's Online Oracle ERP system. All Bidders must be registered in advance of submitting a Bid. Technical questions should be submitted through Owner's Online Oracle ERP system as an online discussion. Contractor registration in accordance with Title 2.2, Chapter 43 and Title 54.1, Chapter 11, Code of Virginia is required.

The Project or Work consists of improvements to the existing gravity sewer system to include: replacement of 1,725 linear feet of 18-inch VCP with 24-inch PVC pipe; rehabilitation, by means of CIPP liner, of 1,800 linear feet of 18-inch, 1,733 linear feet of 27-inch, and 273 linear feet of 30-inch pipe; replacement of seven manholes with polymer structures; and rehabilitation of 12 manholes. This project also includes pavement mill and overlay, maintenance of traffic and maintenance of service.

A Bid Bond in the amount of 5 percent of the Bid shall be submitted electronically with each Bid.

This project is being funded in part under the Virginia Clean Water Revolving Loan Fund (VCWRLF). Bidders shall comply with the President's Executive Order No. 11246 (Prohibiting discrimination in employment regarding race, color, creed, sex or national origin), No. 12138 and No. 11625 (Regarding MBE/WBE utilization). Bidders shall also comply with the Civil Rights Act of 1964.
