SIXTH AMENDMENT TO CONSENT DECREE

WHEREAS, the parties have conferred and agreed to certain non-material modifications in accordance with Paragraph 166 of the Consent Decree;

WHEREAS, the parties are filing this Sixth Amendment to the Consent Decree with the Court for public transparency and to provide notice to the Court, although Court approval is not required for non-material modifications;

WHEREAS, Paragraphs 24-28 of the Consent Decree require HRSD to, among other things, implement an approved Condition Assessment Plan, and as part of those efforts implement an approved Rehab Action Plan;

WHEREAS, certain projects planned to be undertaken under the Rehab Action Plan have no operational issues presenting a risk of material failure and their removal from the plan will not result in any change to the environmental benefits secured by the Consent Decree;

WHEREAS, certain approved projects with interim deadlines to be undertaken under the Rehab Action Plan will exceed original design costs by approximately \$50-\$100 million and require among other things, redesign, rebidding, contracting, and implementation, and those efforts will take additional time and will result in as good or better environmental benefits;

WHEREAS, on March 10, 2023, a dredge vessel struck and destroyed an HRSD 20-inch force main crossing the intercoastal waterway which has forced a delay in construction of the AT-R4 Great Bridge Interceptor Extension 16-Inch Replacement project;

WHEREAS, HRSD is implementing the Great Bridge Interceptor Force Main Emergency Replacement (SF-180) project to replace the damaged line which requires multiple Federal and Local Permits and easements.

WHEREAS, HRSD has consistently met the requirements of Paragraph 34.f. of the Consent Decree regarding the inspection of force mains near water supplies, and HRSD wishes to broaden the scope of the area of these inspections in order to assess additional pipes and due to concerns about maintaining the integrity of the force mains being inspected;

WHEREAS, Paragraph 59.e. of the Consent Decree provides that the parties can modify the schedule of Phase 1 and Phase 2 projects in writing (consistent with subparagraph 50.d.) and the modification of the schedule proposed in these amendments will provide as good or better environmental benefits than the original scheduling of these projects;

WHEREAS, HRSD represents that it maintains digital copies of the documents, records, and other information required by Paragraph 148 of the consent decree;

NOW, THEREFORE, for good cause shown, the Consent Decree is hereby modified as follows:

- 1) With respect to the projects in the Rehab Action Plan which are being implemented as part of the Condition Assessment Plan:
 - a. GN-R11 will be deleted from the Rehab Action Plan Phase II Projects;
 - b. For the GN-R8 Interceptor System Valve Improvements Phase I: 11 appurtenances have no operational issues presenting a risk of material failure and shall be deleted from the GN-R8 project list:
 - i. Valve Guide No. W2016, Valve 3, Line No. NF-005;
 - ii. Valve Guide No. W1004, Valve 1, Line No. NF-007;
 - iii. Valve Guide No. W1004, Valve 2, Line No. NF-007;
 - iv. Valve Guide No. W3003, Valve 4, Line No. NF-163;
 - v. Valve Guide No. W1004, Valve 9, Line No. NF-172;
 - vi. Valve Guide No. W1004, Valve 4, Line No. NF-172;
 - vii. Valve Guide No. W1004, Valve 10, Line No. NF-172;
 - viii. Valve Guide No. W1004, Valve 6, Line No. NF-192;
 - ix. Valve Guide No. AT6042, Valve 6, Line No. SF-101;
 - x. Valve Guide No. AT1159Q, Valve 1, Line No. SF-209;
 - xi. Valve Guide No. AB1003, Valve 3, Line No. SF-002;
 - c. For the VIP-R1 Central Norfolk Area Gravity Sewer Improvements: the scope of the project will be reduced from 9,900 linear feet of sewer pipe and 58 manholes to approximately 9,629 linear feet of sewer pipe and 15 manholes;

- d. The deadline for the VIP-R1 Central Norfolk Area Gravity Sewer Improvements project will be extended from May 5, 2025 to May 5, 2026;
- e. The deadline for the VIP-R6 Ferebee Avenue Pump Station Replacement/Rehabilitation project will be extended from May 5, 2025 to May 5, 2026;
- f. The deadline for the AT-R6 Doziers Corner Pump Station and Washington District Pump Station Flooding Mitigation Improvements project will be extended from May 5, 2025 to May 5, 2027;
- g. The deadline for the VIP-R10 Larchmont Area Pump Station Replacements project will be extended from May 5, 2025 to May 5, 2027;
- h. The deadline for the VIP-R11 Lafayette Norview-Estabrook Pump Station Replacements project will be extended from May 5, 2025 to May 5, 2027; and
- i. The deadline for the NP-R2 Shingle Creek and Hickmans Branch Gravity Sewer Improvements project will be extended from May 5, 2025 to May 5, 2027.
- j. The deadline for the AT-R4 Great Bridge Interceptor Extension 16-Inch Replacement project is revised to "as expeditiously as possible, but no later than two years following substantial completion of the Great Bridge Interceptor Force Main Emergency Replacement (SF-180)."
- k. The deadline for the Phase 2 Rehab Action Projects listed in Appendix 1 to this Sixth Amendment to the Consent Decree are extended from May 5, 2025 to December 31, 2025.
- 2) Paragraph 34.f. of the Consent Decree shall be amended to read: Non-invasive force main inspection for pipes within 2,500 feet of a drinking water supply reservoir, 2,400 linear feet per year.
- 3) As reflected in Appendix 2 to this Sixth Amendment to the Consent Decree, certain High Priority Projects in the approved Regional Wet Weather Management Plan ("RWWMP") will be moved from Round 1 to Round 2, and vice versa. This Sixth Modification constitutes approval of the new enforceable Interim Completion dates for High Priority Projects in the RWWMP, as reflected in Appendix 3 to this Sixth Amendment to the Consent Decree.

4) Paragraph 149 of the Consent Decree shall be amended to read:

At the conclusion of the 5-year information retention period in Paragraph 148, HRSD may discard hard copies of the documents, records, or other information subject to the requirements of Paragraph 148.
