Notice of Listed Event – Modification to Rights of Security Holders; <u>Modification to Terms of Financial Obligation</u>

In accordance with the continuing disclosure undertakings made by the Hampton Roads Sanitation District (the "District") in connection with the issuance of the bonds identified on Exhibit A hereto (the "Bonds"), notice of the following event with respect to the District is hereby provided:

The District and The Bank of New York Mellon Trust Company, N.A., as trustee, have entered into the Trust Agreement (Securing Senior Obligations), dated as of March 1, 2008, between the District and The Bank of New York Mellon Trust Company, N.A., as trustee, as amended and supplemented (the "Senior Trust Agreement").

The District and The Bank of New York Mellon Trust Company, N.A., as trustee, have also entered into the Trust Agreement (Securing Subordinate Obligations), dated as of October 1, 2011, as amended and restated as of March 1, 2016, between the District and The Bank of New York Mellon Trust Company, N.A., as trustee, as amended and supplemented (the "Subordinate Trust Agreement").

The District and the Virginia Resources Authority (the "Authority"), as Administrator of the Virginia Water Facilities Revolving Fund, have entered into a Sixth Amendment, dated as of August 1, 2023, effective as of August 31, 2023 (the "VRA Master Financing Agreement Amendment"), to the Master Financing Agreement, dated as of February 1, 2016, by and between the District and the Authority, as previously amended and supplemented (the "Existing VRA Master Financing Agreement").

Pursuant to the Existing VRA Master Financing Agreement relating to obligations issued to the Authority and secured under the Senior Trust Agreement ("VRA Senior Bonds") and obligations issued to the Authority and secured under the Subordinate Trust Agreement ("VRA Subordinate Obligations" and collectively with the VRA Senior Bonds, the "VRA Obligations"), the Authority and the District have agreed that, under certain conditions set forth in the Existing VRA Master Financing Agreement, some or all of the VRA Senior Bonds will become VRA Subordinate Obligations secured as Parity Obligations under the Subordinate Trust Agreement and will no longer be Senior Obligations secured under the Senior Trust Agreement (the "Migrating VRA Senior Bonds"). The Migrating VRA Senior Bonds will, from time to time, convert from VRA Senior Bonds to VRA Subordinate Obligations, subject to the conditions set forth in the VRA Master Financing Agreement.

The District has met the conditions set forth in the Existing VRA Master Financing Agreement for all remaining VRA Senior Bonds in the aggregate outstanding principal amount of \$22,817,880.56 (as of August 31, 2023) to convert from Senior Obligations to VRA Subordinate Obligations, as described in Exhibit B hereto.

Accordingly, all VRA Obligations that were previously VRA Senior Bonds have become VRA Subordinate Obligations.

No representation is made as to the correctness of the CUSIP numbers either on the Bonds or in this Notice.
