Notice of Listed Event

In accordance with the continuing disclosure undertakings made by the Hampton Roads Sanitation District (the "District") in connection with the issuance of the bonds identified on Exhibit A hereto (the "Bonds"), notice of the following event with respect to the Bonds is hereby provided:

On October 14, 2014, the District deposited the amount of \$45,207,112 (the "Deposit Amount") to the Debt Service Reserve Fund established pursuant to the Trust Agreement, dated as of March 1, 2008 (as amended and supplemented to the date hereof, the "Trust Agreement"), between the District and the predecessor in interest to The Bank of New York Mellon Trust Company, N.A., as trustee (the "Trustee"), relating to the Senior Obligations (as defined in the Trust Agreement) of the District. "Senior Obligations" does not include the Subordinate Bonds referred to in this Notice or any other Subordinated Indebtedness, as defined in the Trust Agreement, of the District.

The Deposit Amount is at least equal to the Debt Service Reserve Fund Requirement, calculated in accordance with the Trust Agreement. The Trust Agreement requires the District to transfer to the Trustee amounts equal to the Debt Service Reserve Funding Requirement within six months of the commencement of a Reserve Funding Period (as defined in the Trust Agreement). The Reserve Funding Period began on December 31, 2010 (six months after the end of the fiscal year in which the Long-Term Debt Service Coverage Ratio for all Long-Term Indebtedness of the District [each as defined in the Trust Agreement] was less than 1.35). The District incorrectly calculated the Long-Term Debt Service Coverage Ratio for the fiscal years during the Reserve Funding Period and as a result failed to make the required transfer of funds to the Debt Service Reserve Fund until the date of this Notice. Throughout the current Reserve Funding Period, the District has had on hand unrestricted cash and liquid, short-term investments in an amount sufficient to make such transfer.

No representation is made as to the correctness of the CUSIP numbers either on the Bonds or in this Notice.
