Notice of Listed Event – Other

In accordance with the continuing disclosure undertakings made by the Hampton Roads Sanitation District (the “District”) in connection with the issuance of the bonds identified on Exhibit A hereto (the “Bonds”), notice of the following event with respect to the District is hereby provided:

On August 10, 2017, the District issued its Subordinate Wastewater Revenue Bond (the “2017 Ferguson Local Bond”) in the principal amount of \$1,000,000 to the Virginia Resources Authority (the “Authority”), as Administrator of the Virginia Water Facilities Revolving Fund (the “Fund”), in order to provide financing for improvements to the District’s Ferguson Park Interceptor.

The 2017 Ferguson Local Bond bears interest at the rate of 2.70% per annum, payable on September 1, 2018, and thereafter principal and interest payable on each March 1 and September 1, commencing March 1, 2019, and a final maturity date of March 1, 2047.

The 2017 Ferguson Local Bond is issued in accordance with the Master Financing Agreement, dated as of February 1, 2016, as amended to the date hereof, and as supplemented by the Supplement to Master Financing Agreement, dated as of August 1, 2017, each between the Authority, as Administrator of the Fund, and the District.

The 2017 Ferguson Local Bond is secured under the Trust Agreement, dated as of October 1, 2011, by and between the District and The Bank of New York Mellon Trust Company, N.A., as trustee, as amended and restated on March 1, 2016 (as so amended and restated, the “Trust Agreement”). Under the Trust Agreement, the 2017 Ferguson Local Bond is secured on a parity with all Parity Obligations (as defined in the Trust Agreement) of the District and subordinated to all Senior Indebtedness, as defined, and to the extent set forth, in the Trust Agreement.

No representation is made as to the correctness of the CUSIP numbers either on the Bonds or in this Notice.
